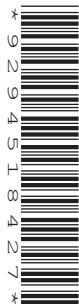

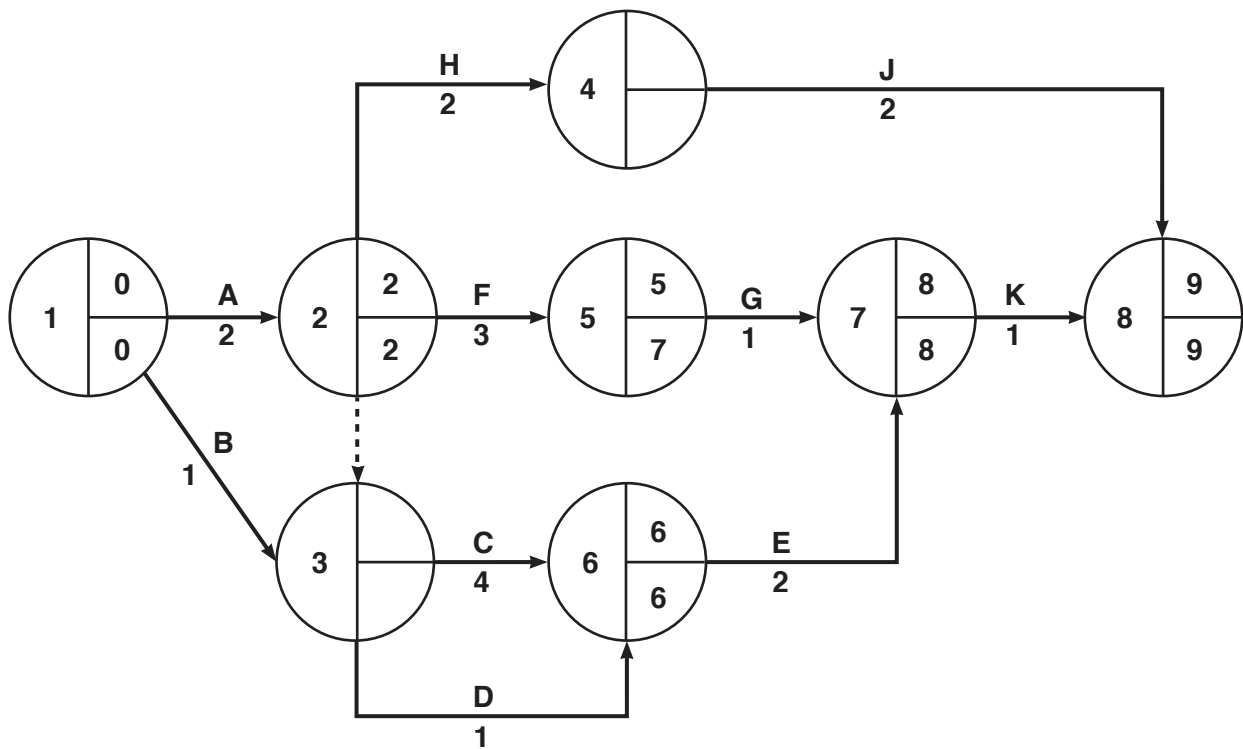


Fig. 1: Network diagram for opening new café
