



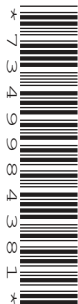

Answer questions from **two** different options.

**Production, location and change**

If answering this option, answer Question 1 and **either** Question 2 **or** Question 3.

- 1** Fig. 1.1 shows the percentage change in manufacturing jobs, by level of education, in the UK, an HIC in Europe, 2012–17.
- (a) Describe the main changes shown in Fig. 1.1. [4]
- (b) Explain **two** ways labour may affect the location of manufacturing industry. [6]
- 2** Assess the extent to which issues in the intensification of agriculture are less important than the increase in agricultural productivity. [20]
- 3** With reference to **one** country's management of change in manufacturing industry, assess the extent to which the issues faced have been overcome. [20]

**Environmental management**

If answering this option, answer Question 4 and **either** Question 5 **or** Question 6.

- 4** Fig. 4.1 shows the population without basic drinking water services, by world region, 2000–20.
- (a) Describe the main changes in the population without basic drinking water services shown in Fig. 4.1. [4]
- (b) Suggest reasons why there may be an increase of population without basic drinking water services in a region. [6]
- 5** With reference to **one** country's overall electrical energy strategy, assess the extent to which changes in the location of power production led to issues. [20]
- 6** 'Successful protection of environments at risk depends on overcoming constraints.'
- With reference to one or more examples, how far do you agree with this statement? [20]

**Global interdependence**

If answering this option, answer Question 7 and **either** Question 8 **or** Question 9.

- 7 Fig. 7.1 shows the net debtor or net creditor status of a country in 2020.
- (a) Describe the distribution of countries with a **net debtor** status shown in Fig. 7.1. [4]
- (b) Explain **two** causes of international debt. [6]
- 8 Assess the extent to which global patterns of trade are influenced by changes in the global market. [20]
- 9 With reference to **one** tourist area or resort, assess the extent to which the impacts of tourism change over time. [20]

**Economic transition**

If answering this option, answer Question 10 and **either** Question 11 **or** Question 12.

- 10 Fig. 10.1 shows the annual growth rate of world real gross domestic product (GDP), 2006–20 and estimated to 2021.
- (a) Describe the trends of annual growth rate of real GDP shown in Fig. 10.1. [4]
- (b) Explain why **two** social indices are effective at showing inequality. [6]
- 11 Assess the extent to which global inequalities in social and economic well-being are caused by physical factors. [20]
- 12 Assess the extent to which the global pattern of production is caused by the new international division of labour (NIDL). [20]
