Generic Marking Principles

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

GENERIC MARKING PRINCIPLE 2:

Marks awarded are always **whole marks** (not half marks, or other fractions).

GENERIC MARKING PRINCIPLE 3:

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

GENERIC MARKING PRINCIPLE 4:

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

GENERIC MARKING PRINCIPLE 5:

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

**Social Science-Specific Marking Principles
(for point-based marking)****1 Components using point-based marking:**

- Point marking is often used to reward knowledge, understanding and application of skills. We give credit where the candidate's answer shows relevant knowledge, understanding and application of skills in answering the question. We do not give credit where the answer shows confusion.

From this it follows that we:

- a** DO credit answers which are worded differently from the mark scheme if they clearly convey the same meaning (unless the mark scheme requires a specific term)
- b** DO credit alternative answers/examples which are not written in the mark scheme if they are correct
- c** DO credit answers where candidates give more than one correct answer in one prompt/numbered/scaffolded space where extended writing is required rather than list-type answers. For example, questions that require *n* reasons (e.g. State two reasons ...).
- d** DO NOT credit answers simply for using a 'key term' unless that is all that is required. (Check for evidence it is understood and not used wrongly.)
- e** DO NOT credit answers which are obviously self-contradicting or trying to cover all possibilities
- f** DO NOT give further credit for what is effectively repetition of a correct point already credited unless the language itself is being tested. This applies equally to 'mirror statements' (i.e. polluted/not polluted).
- g** DO NOT require spellings to be correct, unless this is part of the test. However spellings of syllabus terms must allow for clear and unambiguous separation from other syllabus terms with which they may be confused (e.g. Corrasion/Corrosion)

2 Presentation of mark scheme:

- Slashes (/) or the word 'or' separate alternative ways of making the same point.
- Semi colons (;) bullet points (•) or figures in brackets (1) separate different points.
- Content in the answer column in brackets is for examiner information/context to clarify the marking but is not required to earn the mark (except Accounting syllabuses where they indicate negative numbers).

3 Calculation questions:

- The mark scheme will show the steps in the most likely correct method(s), the mark for each step, the correct answer(s) and the mark for each answer
- If working/explanation is considered essential for full credit, this will be indicated in the question paper and in the mark scheme. In all other instances, the correct answer to a calculation should be given full credit, even if no supporting working is shown.
- Where the candidate uses a valid method which is not covered by the mark scheme, award equivalent marks for reaching equivalent stages.
- Where an answer makes use of a candidate's own incorrect figure from previous working, the 'own figure rule' applies: full marks will be given if a correct and complete method is used. Further guidance will be included in the mark scheme where necessary and any exceptions to this general principle will be noted.

4 Annotation:

- For point marking, ticks can be used to indicate correct answers and crosses can be used to indicate wrong answers. There is no direct relationship between ticks and marks. Ticks have no defined meaning for levels of response marking.
- For levels of response marking, the level awarded should be annotated on the script.
- Other annotations will be used by examiners as agreed during standardisation, and the meaning will be understood by all examiners who marked that paper.

Using the mark scheme

Some of the questions are marked holistically using levels of response mark schemes. When marking holistically, the marks awarded for an answer are usually based on a judgement of the overall quality of the response.

For holistic marking, inevitably, the mark scheme cannot cover all responses that candidates may make for all of the questions. In some cases, candidates may make some responses which the mark scheme has not predicted. These answers should nevertheless be credited according to their quality.

Reward a maximum of two factors. 2(b)	Explain <u>one</u> strength and <u>one</u> limitation of using content analysis as a research method. Indicative content Strengths • High in reliability. • Can identify underlying themes and patterns encoded in representations. • Produces (quantitative) data which is easily comparable – across media, over time, between societies. • Practical: cheap to produce – from easily available sources [TV, newspapers and internet.] • May have a predictive element. • Can be used easily in combination with other methods e.g. semiology. • Any other appropriate strength. Limitations • Potential for researcher bias - coding categories may be affected by the researcher's values. • Only collects a quantitative tally of frequency. • Data needs to be interpreted by the researcher – this can be subjective. • The audience understanding of media messages is not known. • Any other appropriate limitation. Reward a maximum of one strength. For this strength, up to 3 marks are available: 1 mark for identifying a strength of content analysis (e.g. high in reliability) 1 mark for explaining why this method has this strength (e.g. uses a coding system which can be easily replicated by another researcher). 1 mark for explaining why it is a strength (e.g. this entails that when the same research is repeated by another researcher the results will be the same.) Reward a maximum of one limitation. For this limitation, up to 3 marks are available: 1 mark for identifying a limitation of content analysis (e.g. potential for researcher bias) 1 mark for explaining why this method has this limitation (e.g. coding categories may be affected by subjective judgements) 1 mark for explaining why it is a limitation (e.g. researchers may make decisions made about categories and the assignment of behaviour which may be different to other researchers) (2 × 3 marks)	6

3(a)	‘Under-socialisation is the main reason that individuals act in deviant ways.’ Explain this view. Indicative content - Under-socialisation is the idea that some groups experience inadequate socialisation which can negatively impact on their behaviour. - Failings in early socialisation and family background mean that many young people are raised without appropriate norms, values and attitudes which means they are likely to behave in deviant ways. - Some sociologists argue that there is a growing underclass who account for a great deal of criminal behaviour. This concept is often linked to the idea of an overgenerous welfare system which they argue makes it easier for young women to be single mothers and for men to reject the idea that it is important to have a job. - Any other reasonable point. Levels of response Level 3: 8–10 marks - Good knowledge and understanding of the view that under-socialisation is the main reason that individuals act in deviant ways. The response contains two clear and developed points. - Sociological materials such as concepts, theories and evidence, will be used to support both points. The material selected is appropriate and focused on the question with its relevance made clear. Level 2: 4–7 marks - Some knowledge and understanding of the view that under-socialisation is the main reason that individuals act in deviant ways. The response contains one clear and developed point and one relevant but underdeveloped point. - Sociological material is used to support at least one point. The material selected is appropriate but not clearly focused on the question or its relevance is not made clear. Level 1: 1–3 marks - Limited knowledge and understanding of the view that under-socialisation is the main reason that individuals act in deviant ways. Indicative content • Critique of the explanation in terms of differences in culture rather than under-socialisation (subcultural); • It is very difficult to measure/define what constitutes under-socialisation, and so it is difficult to study whether under-socialisation is the main cause of deviance; • It fails to explain the occurrence of deviant acts among individuals and groups who might be expected to have experienced adequate socialisation, such as university students and those from the middle class who commit white-collar crime; • Social resistance; • Marginalisation – approaches that view the relationships between different groups as shaped by power leads to some marginalised/resistant groups (e.g. The young) being ‘labelled’ as deviant etc.; • Biological/psychological explanations for deviant behaviour focusing on deficient personalities more prone to deviance; • Evidence of the persistence of social pressure promoting conformity (social exchange theory); • Structural approaches that focus on socio-economic factors that give rise to deviant/criminal behaviour. • Any other relevant argument Levels of response Level 3: 5–6 marks • One clear and developed argument against the view that under-socialisation is the main reason that individuals act in deviant ways. • Sociological material, such as concepts, theories and evidence, is used to support the argument.
